Additional information such as plat of survey, contracts/proposals and license information may be required with application based on the type of project. I hereby declare that the information herein and attached is correct and agree in consideration of and upon issuance of permit, to do or allow to be done only such work as herewith applied for and that such premises and its existing and proposed building and structures shall be used or allowed to be used for only such purposes as set forth. In addition, when a permit for work is described in this application is issued, I certify that the Code Official or the Code Official's authorized representative shall have the authority to enter areas covered by such permit at any reasonable hour to enforce the provisions of the code(s) applicable to such permit. I also shall contact the Building Department at least 24 hours in advance for inspections. Your compliance with your respective Homeowner's Association and covenants is your responsibility, not the Village's.
